#### CME – SOFR Rate Index Transition

As a part of SOFR transition, the CME CCP will be transitioning price alignment and discounting for USD OTC Cleared Swaps from daily Effective Federal Funds Rate (EFFR) to SOFR in October, 2020.

To implement this discounting change, CME will generate a discounting transition report IRSDIS after the standard EOD cycle (which uses EFFR discounting/PA) on 16<sup>th</sup> Oct, '20.

As the discounting rate will change, there will be a difference in the NPV value when compared to the EFFR discounted NPV value. To neutralize this value transfer from the change to SOFR discounting, CME will be processing a cash adjustment that is equal and opposite to the NPV change on each trade in all accounts. All these details will be provided in the IRSDIS file.

#### **IRSDIS Processing**

The following CME report will be used via CDML jobs to import the cash adjustments:

#### Discounting Transition report - IRSDIS\_HSS\_323\_20200619\_EOD.nr.csv

The IRSDIS report will be generated only on the transition day (Saturday) to provide the cash adjustment changes. This is an optional report and should be processed if available with the existing files. After the transition day, this report will not be generated and is only a one-time report. EOD clearing will be processed with the current existing files IRSMR3 / IRSTR files as usual after the transition day.

#### IRSDIS Specific Handling

To reflect the correct cash adjustments in the system, Prev NPV (based on EFFR discounting) will be imported from IRSDIS and the cash adjustments will be added to the Upfront fees.

This file will be processed as a part of the regular processing cycle on Monday (after the transition) along with other EOD files which will be dated as of Monday.

CDML will only be able to import the IRSDIS file if the file-date and the valuation date in the file matches the Monday valuation date.

Hence, you need to change the IRSDIS file-date and valuation as per the Monday valuation date to process it.
